ON 01/09/2005, THE STAFF PERSON (RANDY MELLO) STUFFED [REDACTED] INTO A LAUNDRY BAG BECAUSE HE CAME BACK TO THS ISP, AND BECAUSE [REDACTED] IS ANNOYING". THIS HAD NOT HAPPENED BEFORE, BUT AGAIN ON 01/10/2005, THE SAME STAFF PERSON STUFFED [REDACTED] INTO A LAUNDRY BAG. WHEN [REDACTED] TRIED TO CHEW THROUGH THE STRINGS OF THE LAUNDRY BAG, THE STAFF PERSON PUT HIS FOOT ON [REDACTED] FACE INTENTIONALLY, AND [REDACTED] THEN COULD NOT BREATHE. THE STAFF PERSON ALSO ALLOWED OTHER RESIDENTS TO "TORTURE" [REDACTED]. AS A RESULT OF HIS CONFINEMENT IN THE BAG, [REDACTED] SUSTAINED CUTS FROM ONE RESIDENT NAMED [REDACTED] WHO PUT THREE FINGERS INTO THE BAG AND SCRATCHED [REDACTED] FOREARM.
