**Drug/Alcohol Involvement:**

Ms. Larry has [redacted]. She attended treatment through her church and stated that she has not [redacted]. Her pastor stated that the [redacted] consists of teaching people "life skills" and that it lasts about 9 months.

**References and other Documents:**

Emily Rowell, friend, stated that Ms. Larry is loving, successful and honest. She believes she has come through her adversity. Gary Lloyd, friend of 16 years, stated

that Ms. Larry has turned her life around and believes that she can "go far" if given the chance. Pastor Smalley stated that Ms. Larry and her family have attended his church since 2005 and that her parents and grandparents have attended that church for "many years". He stated that she is very involved in the church.
